Wakf, the Board of Mutwalli of the Wakf or any persons interested therein may institute a suit in the Wakf Tribunal Aurangabad for the decision of the question, within a period of one year from the date of publication of lists of Wakf under Section 5(2) of the Wakf Act, 1995.
