No. WKF-MIS-4106-73.—Whereas the Government of Maharashtra under sub-section 5 (1) of section 4 of Wakf Act, 1954, has forwarded a list of Wakf properties to the Marathwada Wakf Board for publication after scrutiny;

The Marathwada Wakf Board after the scrutiny is publishing the list of Wakf under sub-section 5 (2) of section 4 of the said Act. If a dispute arises as to whether or not the property specified in the list is Wakf property or it pertains to Sunni or Shia Wakf, the Board, Mutawalli, or the person interested may institute a suit in a Civil Court as laid down in section 6 (1) within a period of one year from the date of publication of list of Wakf under sub-section (2) of section 5.

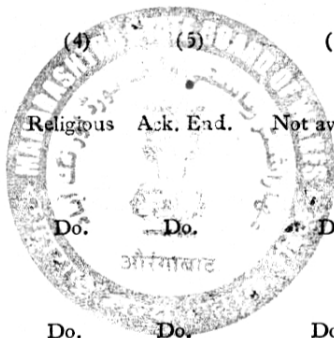
