The Maharashtra State Board of Wakfs, Aurangabad is publishing the lists of Wakfs under Section 5(2) of the said Act, forwarded by Government of Maharashtra. If a dispute arised whether a particular property specified as Wakf property in the lists is a Shia Wakf or Sunni Wakf, the Board or Mutwalli of the Wakf or any persons interested therein may institute a suit in the Wakf Tribunal Aurangabad for the decision of the question, within a period of one year from the

date of publication of lists of Wakf under Section 5(2) of the Wakf Act, 1995.
