The Maharashtra State Board of Wakf, Aurangabad after scrutiny Resolved in the Board meeting held on 27th September 2003 to publish the lists of Wakfs under section 5(2) of the Central Wakf Act, 1995. The Maharashtra State Board of Wakfs, Aurangabad is publishing the lists of Wakfs under Section 5(2) of the said Act, forwarded by Government of Maharashtra. If a dispute arised whether a particular property specified as Wakf property in the lists is a Shia Wakf or Sunni Wakf, the Board or Mutwalli of the Wakf or any persons interested therein may institute a suit in the Wakf Tribunal Aurangabad for the decision of the question, within a period of one year from the

date of publication of lists of Wakf under Section 5(2) of the Wakf Act, 1995.
