Subject:- Delegation of powers pertaining to the
Supervision of Kazasat
Institution to the Regional Committee of
Marathwada. xx

Sir,

With reference to your letter No. 119 dated 18th January, 1959,
on the above subject, I am directed to state that consequent upon the
extension of the Muslim Wakfs Act, 1954, to the areas of the former
Hyderabad State, the Supervision over Kazis has been entrusted to the
Muslim Wakfs Board. It is the Muslim Wakfs Board which is solely res-
ponsible for the administration of Kazasat. Government has nothing
to do with Kazasat.

2. With the transfer of Supervision over the work of the Kazasat
to the Regional Committee of Muslim Wakf Board Aurangabad, this
Government will not be in any way concerned with the Supervision over
the work of Kazis unless payment of any cash allowance is involved. It
will not, therefore, be necessary to preserve marriage certificates in
respect of marriages performed by Kazis.

In view of the position as stated above, instructions are being
issued that 4 copies of certificates of each marriage shall have to be
prepared hence forth, and no copy thereof will be deposited with the
Government for Government's records. You are therefore, requested to
transfer the record of copies of Siahas with the Government of Andhra
Pradesh to the Regional Committee of the Muslim Wakf Board for the M
Marathwada Wakf B area, Aurangabad.
